

### Without AAI




## SW/ITCH

- Tedious user registration at all resources
- Unreliable and outdated user data at resources
- Different login processes
- Many different passwords
- Many resources not protected due to difficulties
- Often IP-based authorization
- Costly implementation of inter-institutional access



### With AAI


- No user registration and user data maintenance at resource needed
- Single login process for the users
- Many new resources available for the users
- Enlarged user communities for resources
- Authorization independent of location
- Efficient implementation of inter-institutional access












SWITCH acts as federation service provider

Federation membership based on signed service agreements







#### **Virtual Home Organization Service**



The VHO enables Resource Owners to create "AAI-enabled" accounts for users not belonging to a Home Organization.
Such an account will only be valid for a single resource (or a limited set of resources) belonging to such a Resource Owner.





#### funding / costs





- "New Cooperation Projects" SUC (2004 2007)
  - Asked for: 10 MCHF (4 MCHF for SWITCH, 6 MCHF for the universities)
  - Involved committees
    - » decisive role: Swiss University Conference SUC
    - » preparative role: CRUS, KFH, SKPH
  - Granted: 5.2 MCHF on 14 October 2004
    - » 3.2 MCHF for the cantonal universities ("matching funds" required)
    - » 2.0 MCHF for SWITCH
- OPET Subsidies for the UAS (2004 2007)
  - Approx. 1.2 MCHF for AAI projects (out of 3.2 MCHF)
- ETH Domain (SFIT Zurich and Lausanne)
  - Contribution on own accounts of 2.0 MCHF
- Execution of the SUC cooperation projects
  - Coordination by SWITCH
  - Cooperation with universities based on projects (proposals to be submitted to SWITCH until 30 April 2005)
